this cur INDENTED CERTIFICATE, for the Sum of *One hundred and eighty one Pounds five Shillings Sterling* for *Militia Duty* as a *Lieutenant and Captain* in 1780 and 1781 as *of Account & Audited*

the said *Thomas Lindsey*
his Executors, Administrators, or Assigns, will be entitled to receive from this Office the Sum of *Twelve pounds, three Shillings and nine pence* on *the Demand* for one Year's Interest on the principal Sum of *One hundred and eighty one Pounds five Shillings* and the like Interest annually

The said *Thomas Lindsey* his Executors, Administrators or Assigns, will be entitled also to receive, and shall be paid, if demanded, the principal Sum of *One hundred and eighty one pounds five Shillings* on the *Twenty ninth of December 1787* And the said *Thomas Lindsey* his Executors, Administrators or Assigns, may make any Purchases at any Public Sales of Confiscated Property, (except such as shall be ordered by the Legislature for special Purposes;) and this INDENT shall be received in Payment.

For the true Performance of the several Payments in Manner above-mentioned, the PUBLIC TREASURY is made liable, and the FAITH of the STATE pledged by the afore said ACT.
